At Bexton Primary School we ensure pupil premium children have equal access to extra-curricular activities. It is made clear to parents on the residential (Y5) paper work that we can assist with the payment of the trip. We funded this to the cost of £560. We paid £493 in music tuition costs and £95 towards the costs of extra-curricular activities.
